## Terms and Conditions – Winter Warmers Campaign Entry Prize

- 1. "We", "Kingswim" and "Promoter" are YMCA Aquatic Education Ltd (ABN 88 151 552 322) of 2 St Catherine's Court, Mornington, telephone (03) 5975 0777.
- 2. Information on eligibility, how to enter and the prize form part of these Terms and Conditions (**Terms**).
- 3. Participation in this Promotion (**Promotion**) is deemed acceptance of these Terms (including any subsequent variations to these Terms as provided for in these Terms).

- 10.
